**CM-16623-CII-2025**

This is an application under Section 151 CPC for preponing the date of hearing in the appeal.

Learned counsel for the applicant-appellant has submitted that since the matter has been compromised, the matter be preponed from 06.11.2025 to today.

In view of the above, the present application is allowed and the appeal is preponed from 06.11.2025 to today itself.

**CM-16624-CII-2025**

This is an application under Order 22 Rule 3 read with Section 151 CPC for bringing on record the legal representatives of deceased



appellant.

For the reasons stated in the application, which is duly supported by an affidavit and the averments mentioned in the application, the present application is allowed subject to all just exceptions and the persons mentioned in paragraph 4 of the application are ordered to be impleaded as the legal representatives of the appellant.

It is clarified that this Court has not adjudicated upon the right of the estate of the appellant and the LR's have been impleaded only to pursue the present appeal.

**CM-16626-CII-2025 & FAO-4214-2022**

This is an application under Order 23 Rule 1 CPC read with Section 151 CPC for allowing the appellant to withdraw the main appeal in view of the compromise effected between the parties.

For the reasons stated in the application as well as the fact that the compromise has been effected between the parties, the present application is allowed and the applicant-appellant is permitted to withdraw the main appeal itself.

**CM-16627-CII-2025**

This is an application under Section 151 CPC directing the Registry of this Court for releasing an amount of Rs.25,000/-.

For the reasons stated in the application and in view of the fact that the present applicant is withdrawing the appeal, thus, the present application is allowed and the Registry is directed to release the amount of
