SANJAY VASHISTH. J.(Oral)

1. Instant petition has been filed under Section 528 of the BNSS, 2023 seeking quashing of DDR No.20, dated 10.07.2020, u/s 323, 341, 506, 148, 149 IPC registered at P.S. City Morinda, Distt. Ropar, in (case/FIR No.78, dated 05.07.2020, u/s 307, 326, 452, 323, 506, 325, 148, 149 IPC, registered at P.S. City Morinda, Distt. Ropar), against the petitioners, in view of the compromise dated 22.03.2025.

2. In the instant compromise quashing petition, on 12.05.2025, following order was passed:-

1. *Instant petition has been filed under Section 528 of the BNSS, 2023 (earlier Section 482 Cr.P.C.), seeking quashing of the below detailed First Information Report (FIR), and all the consequential proceedings arising therefrom, on the basis of the compromise dated 22.03.2025 (Annexure P-3), effected between the parties.*

2. *It is informed that proceedings in the present petition, which are sought to be quashed are in regard to cross-version i.e. DDR No.20, dated 10.07.2020, u/s 323, 341, 506, 148, 149, registered at P.S. City Morinda, Distt. Ropar (Annexure P-1), in case FIR No.78, dated 05.07.2020, u/s 307, 326, 452, 323, 506, 325, 148, 149, registered at P.S. City Morinda, Distt. Ropar (Annexure P-1).*

Counsel for the petitioners also contends proceedings qua the FIR



got lodged at the instance of private respondents No.2 & 3, i.e., FIR No.78, dated 05.07.2020, has already been quashed by this Court vide order dated 30.08.2024, passed in CRM-M-25964-2024, titled as, “Jaspal Singh & Others v. State of Punjab and others”.

3. Learned counsel for the petitioners further submits that all the parties to the dispute, already arrayed as parties in the present petition, have amicably resolved their dispute through compromise dated 22.03.2025 (Annexure P-3). Therefore, if proceedings arising from the aforementioned FIR, and all the consequential proceedings arising therefrom, are quashed, all the parties and their family members will be able to live their lives peacefully.

3. Notice of motion.

4. On asking of the Court, Mr. Luvinder Sofat, Sr. DAG, Punjab, who is present in the Court, accepts notice on behalf of respondent No.1 – State. He seeks time to file status report in the matter.

5. Mr. Gagandeep Singh, Advocate, appears on behalf of respondents No.2 & 3 and admits execution of the compromise (Annexure P-3).

Let requisite copies of the complete paper book be supplied to learned State counsel as well as learned counsel for respondent No.2 during course of the day.

6. The affected parties are directed to appear before the learned Trial Court/Illaq Magistrate, on or before 28.05.2025 or on any other date convenient to said Court, for getting their respective statements recorded with regard to the compromise. Thereupon, the concerned Court shall submit a detailed report, containing the information on the following points, along with copies of the statements to this Court, on or before the adjourned date:-

3. It is informed by the petitioner’s counsel that, from the same incident, FIR No. 78 dated 05.07.2020, under sections 307, 326, 452, 323, 506, 325, 148, and 149, registered at P.S. City Morinda, Distt. Ropar against the complainant party, has already been quashed. The instant DDR No. 20 dated 10.07.2020, under sections 323, 341, 506, 148, and 149, registered at P.S. City Morinda, Distt. Ropar, arising out of the same incident as a cross version against the petitioners and the said dispute between the parties have been compromised.

4. Pursuant to the aforementioned order, the parties appeared before the Court of learned Judicial Magistrate First Class, Rupnagar, and as per report dated 04.06.2025, submitted to this Court, both the parties have got recorded their respective statements in Court. From the report received from the learned Court below, the following is discernible:-

5. Learned counsel for the petitioner(s) submits that in view of the report received from the learned Court Below, it is evident that the matter has been resolved and private parties have effected a compromise, and there remains no dispute amongst them requiring any adjudication. Further submits that in view of the compromise so effected between the private parties, pendency of the FIR and consequential proceedings emanating therefrom would be sheer abuse of the process of law, and the same may be quashed.

6. Learned State counsel as also learned counsel for private respondent(s), after going through the statements and the report received from learned Court below, very fairly admit that the private parties have resolved their dispute and effected a compromise and that they have no objection if the FIR (supra) and all the consequential proceedings are quashed on the basis of the compromise.

7. Through catena of judgments, Hon’ble the Apex Court and High Courts (including Punjab and Haryana High Court), have culled out various principles of law concerning quashing of proceedings emanating after lodging of FIR, and some of them are as under:-

Power under Section 482 Cr.P.C./Section 528 BNSS can be exercised to enhance social amity, and to reduce friction.

Disputes which have their genesis in a matrimonial discord, landlord-tenant matters, commercial transactions and other such matters can safely be dealt with by the Court by exercising its powers under Section 482 Cr.P.C./Section 528

BNSS in the event of a compromise, but this is not to say that the power is limited to such cases.

There can never be any hard and fast category which can be prescribed to enable the Court to exercise its power under Section 482 Cr.P.C./Section 528 BNSS "to prevent abuse of the process of any Court" or "to secure the ends of justice".

No embargo, be in the shape of Section 320(9) Cr.P.C./Section 359 BNSS, or any other such curtailment, can whittle down the power under Section 482 of the Cr.P.C./Section 528 of the BNSS.

The compromise, in a modern society, is the sine qua non of harmony and orderly behaviour.

High Court has the wide power to quash the proceedings even in non-compoundable offences notwithstanding the bar under Section 320 Cr.P.C./Section 359 BNSS, in order to prevent the abuse of law and to secure the ends of justice.

Power under Section 482 Cr.P.C./Section 528 BNSS is to be exercised Ex-Debitia Justitia to prevent an abuse of process of Court.

Such power has no limits. However, the High Court will exercise it sparingly and with utmost care and caution.

The exercise of power has to be with circumspection and restraint.

The Court is a vital and an extra-ordinary effective instrument to maintain and control social order.

The Courts play role of paramount importance in achieving peace, harmony and ever-lasting congeniality in society.

Resolution of a dispute by way of a compromise between two warring groups, therefore, should attract the immediate and prompt attention of a Court which should endeavour to give full effect to the same unless such compromise is abhorrent to lawful composition of the society or would promote savagery.

Matters which can be categorized as personal in nature or where nature of injuries do not exhibit mental depravity or involves commission of an offence of such a serious nature that quashing of FIR would override the public interest, the Court can quash the FIR in view of the settlement arrived at amongst the parties.

8. After hearing learned counsel for the parties and going through the material available on record, this Court finds that there appears to be substance in the submission of learned counsel for the petitioners that pendency of the present criminal litigation would be abuse of process of law since the chances of conviction of the petitioners are bleak in view of the compromise, so effected between the private parties.

9. The report alongwith statements of the affected parties received from learned Court below would reveal that the complainant/victim person(s) have genuinely effected a compromise with the petitioners and they have no objection, if the impugned FIR and consequential proceedings are quashed.

10. Keeping in view the totality of the facts and circumstances of the case, including the report received by this Court and also, taking into consideration the aforementioned settled principles of law, this petition is accepted and DDR No.20, dated 10.07.2020, u/s 323, 341, 506, 148, 149 IPC registered at P.S. City Morinda, Distt. Ropar, in (case/FIR No.78, dated 05.07.2020, u/s 307, 326, 452, 323, 506, 325, 148, 149 IPC, registered at P.S. City Morinda, Distt. Ropar), against the petitioners, in view of the compromise dated 22.03.2025.

11. Petition stands disposed of.
