Status report dated 25.05.2025 in the form of an affidavit of Deputy Superintendent of Police, Central, Chandigarh, has been filed. The same is taken on record. Copy thereof has been supplied to learned counsel for the petitioner.

2. By way of present petition filed under Section 482 of BNSS, 2023, petitioner seeks anticipatory bail in case FIR as under:

3. Learned counsel for the petitioner submits that in compliance to the order dated 07.05.2025 passed by this Court, the petitioner has already joined the investigation and as such prayed for confirming the interim bail granted vide order dated 07.05.2025.

4. Learned State counsel, on instructions from ASI Ranbir Singh, intimates the Court that the petitioner has joined investigation and is

neither required for further investigation nor for any custodial interrogation.

5. During the course of hearing on 07.05.2025, following order was passed:

*“ 2. It is, inter alia, contended by learned counsel for the petitioner that the petitioner is a lady aged about 25 years having no criminal antecedents and has been falsely implicated in this case without any liability on her part. He further contends that the petitioner was not part of the firm prior to 11.12.2024 when the alleged transaction by the complainant are stated to have taken place as per the FIR.*

*3. Learned counsel for the petitioner has referred to the partnership deed (Annexure P-2) showing the petitioner having joined the partnership on 11.12.2024. He contends that there is no allegation pertaining to the petitioner and has been falsely implicated by the police just to harass her.*

*4. Notice of motion.*

*5. On the asking of the Court, Mr. Manish Bansal, P.P. U.T. Chandigarh, present in Court, accepts notice on behalf of the Staterespondent.*

*6. Learned State counsel on instructions from ASI Rambir Singh submits that there are 02 entries in the account of the petitioner amounting to Rs.5,000/- and Rs.75,000/- and seeks time filing reply/status report in the matter.*

*6. Be filed on or before 27.05.2025.*

*7. In the meanwhile, the petitioner is hereby directed to join investigation within seven days from today and in the event of her arrest, she is ordered to be released on interim bail on his furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. She shall also*

*abide by conditions as envisaged under Section 482(2) of BNSS ”*

6. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 07.05.2025 passed by this Court, interim bail granted vide order dated 07.05.2025 is hereby confirmed, subject to conditions as envisaged under Section 482 (2) of BNSS, 2023. Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; she will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.

7. The petition stands allowed.

8. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
