[1] The present Criminal Writ Petition has been filed under Article 226 of the Constitution of India for issuance of a writ in the nature of '*Mandamus*' directing respondents No. 2 to 5 to protect the life and liberty of the petitioners from the hands of private respondents No. 6 to 8.

[2] Counsel for the petitioner confines his prayer only for issuance of a direction to decide the representations dated 28.04.2025 and 01.05.2025 (Annexures P-2 and P-3, respectively) by the Station House Officer, Police Station Farrukhnagar, District Gurugram-respondent No. 5 and the Assistant Commissioner of Police, Police Headquarter, District Gurugram-respondent No. 4.

[4] Having received advance copy of the petition, Mr. Aashish Bishnoi, D.A.G., Haryana, appears and accepts notice on behalf of the official respondents No. 1 to 5.

[5] In view of the facts of the present case, this Court feels that issuance of notice to private respondents No. 6 to 8 would unnecessarily delay the proceedings, as such, issuance of notice to respondents No. 6 to 8 is dispensed with.

[6] Keeping in view the innocuous prayer made, seeking written response from respondents No. 1 to 5 is also dispensed with.

[7] In view of the above, the present petition is disposed of with the direction to the Station House Officer, Police Station Farrukhnagar, District Gurugram-respondent No. 5 and the Assistant Commissioner of Police, Police Headquarter, District Gurugram-respondent No. 4 to consider and decide the representations dated 28.04.2025 and 01.05.2025 (Annexures P-2 and P-3, respectively) and if some action is warranted, the needful be done in accordance with law, within a period of two months from the date of the receipt of the certified copy of this order.
