1. This petition has been filed under Section 528 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking quashing of FIR No.282 dated 30.09.2021 registered under Sections 406, 420, 120-B, 34 IPC at Police Station Rajaund, District Kaithal (Annexure P-1) along with all subsequent proceedings arising therefrom on the basis of compromise dated 13.05.2025 (Annexure P-2).

2. In view of the fact that the proceedings before the trial Court have since been withdrawn by the respondent-bank. Therefore,

nothing survives in this case. The bank has no objection if the FIR is also quashed.

3. Learned State counsel as well as counsel for respondents No.2 and 3 have not disputed the factum of compromise between the parties.

4. In view of the above, no useful purpose would be served to continue with the proceedings before the trial Court in the instant FIR.

5. Following the principles laid down by the Full Bench judgment of this Court in **Kulwinder Singh and others Versus State of Punjab and another 2007 (3) RCR (Criminal) 1052** and approved by the Hon'ble Supreme Court in **Gian Singh Versus State of Punjab and others (2012) 10 SCC 303**, this petition is allowed and FIR No.282 dated 30.09.2021 registered under Sections 406, 420, 120-B, 34 IPC at Police Station Rajaund, District Kaithal (Annexure P-1) along with all subsequent proceedings arising therefrom on the basis of compromise dated 13.05.2025 (Annexure P-2) are quashed qua the petitioners.

6. Petitioner is directed to deposit a sum of Rs. 10,000/- to be paid with the High Court, Legal Services Committee, Chandigarh.
