1. Instant petition has been filed praying for quashing of DDR No. 027 dated 06.05.2021 (Annexure P-1) in FIR No.161, dated 04.05.2021 registered under Sections 323, 324, 326, 452 and 148 read with Section 149 of Indian Penal Code, 1860 (for short, 'IPC'), at Police Station Ajnala, District Amritsar (Rural) and subsequent proceedings arising therefrom on the basis of compromise deed dated 12.05.2025, Annexure P-3.

2. The DDR in question was lodged by complainant-respondent No.2 and the investigation commenced thereon. However, with the intervention of respectables, finally the parties arrived at settlement and they resolved their *inter se* dispute, which is apparent from Annexure P-3. On the basis of the compromise, the petitioners are praying that continuation of these proceedings would be a futile exercise and an abuse of process of the

Court and thus, the DDR in question and all the subsequent proceedings arising therefrom may be quashed in the interest of justice.

3. This Court vide order dated 29.05.2025 directed the parties to appear before the trial Court/Illaq Magistrate for recording their statements, as contended before the Court, and the trial Court/Illaq Magistrate was also directed to send its report.

4. In pursuance to the same, learned Sub Divisional Judicial Magistrate, Ajnala has sent report dated 21.07.2025. With the report, he has annexed photocopy of the statements of respondent No.2- complainant Dalbir Kaur and the petitioners, namely, Savinder Singh, Gulab Singh, Amrik Singh, Ranjit Singh, Tejpal Singh and Kulwant Singh dated 08.07.2025 and statement of ASI Bhupinder Singh dated 16.07.2025. On the basis of the statements, learned Sub Divisional Judicial Magistrate, Ajnala has concluded in its report that the compromise is genuine, voluntarily and out of free will. It has been mentioned in the report that there are only six accused in the present case i.e. the present petitioners. It is further mentioned in the report that neither the accused have been declared proclaimed offender. As per record, one other criminal case is pending against accused Ranjit Singh s/o Lakha Singh and lodged in Central Jail, Gurdaspur in FIR No.89/2025, under Section 61-1-14 Excise Act, Police Station Sadar Batala.

5. Learned counsel for the petitioners has submitted that the parties have compromised the matter amicably and have decided to get the DDR registered against the petitioners quashed and as such the present petition is liable to be accepted.

6. Learned counsel for respondent No.2 has also pleaded no objection, if the present DDR is quashed.

7. I have heard learned counsel for the parties, perused the record



and the report sent by learned Sub Divisional Judicial Magistrate, Ajnala.

8. A bare perusal of statutory provisions of the 528 of Bhartiya Nagrik Suraksha Sanhita, 2023 would show that the High Court may make such orders, as may be necessary to give effect to any order under this Code or to prevent abuse of the process of any Court or otherwise to secure the ends of justice. Section 359 Bhartiya Nagrik Suraksha Sanhita, 2023 is equally relevant for consideration, which prescribes the procedure for compounding of the offences under the BNS, 2023.

9. Keeping in view the nature of offences allegedly committed and the fact that both the parties have amicably settled their dispute, the continuation of criminal prosecution would be a futile exercise. The Hon'ble Supreme Court in a number of cases including Narinder Singh and others Versus State of Punjab and another, 2014 (6) SCC 466, B.S.Joshi and others vs State of Haryana and another (2003) 4 Supreme Court Cases 675 followed by this Court in Full Bench case of Kulwinder Singh and others Vs. State of Punjab and another, 2007(3) RCR 1052 have dealt with the proposition involved in the present case and settled the law.

10. Thereafter, Hon'ble Supreme Court in Gian Singh vs State of Punjab and another (2012) 10 Supreme Court Cases 303 further dealt with the issue and the earlier law settled by the Supreme Court for quashing of the FIR in State of Haryana vs Bhajan Lal, 1992 Supp (1) SCC 335. Para 61 of the judgment reads as under:-

“61. The position that emerges from the above discussion can be summarised thus: the power of the High Court in quashing a criminal proceeding or FIR or complaint in exercise of its inherent jurisdiction is distinct and different from the power given to a criminal court for compounding the offences under Section 320 of the Code. Inherent power is of wide plenitude



with no statutory limitation but it has to be exercised in accord with the guideline engrafted in such power viz; (i) to secure the ends of justice, or (ii) to prevent abuse of the process of any Court. In what cases power to quash the criminal proceeding or complaint or F.I.R may be exercised where the offender and victim have settled their dispute would depend on the facts and circumstances of each case and no category can be prescribed. However, before exercise of such power, the High Court must have due regard to the nature and gravity of the crime. Heinous and serious offences of mental depravity or offences like murder, rape, dacoity, etc. cannot be fittingly quashed even though the victim or victim's family and the offender have settled the dispute. Such offences are not private in nature and have a serious impact on society. Similarly, any compromise between the victim and offender in relation to the offences under special statutes like Prevention of Corruption Act or the offences committed by public servants while working in that capacity, etc; cannot provide for any basis for quashing criminal proceedings involving such offences. But the criminal cases having overwhelmingly and pre-dominantly civil flavour stand on a different footing for the purposes of quashing, particularly the offences arising from commercial, financial, mercantile, civil, partnership or such like transactions or the offences arising out of matrimony relating to dowry, etc. or the family disputes where the wrong is basically private or personal in nature and the parties have resolved their entire dispute. In this category of cases, the High Court may quash criminal proceedings if in its view, because of the compromise between the offender and the victim, the possibility of conviction is remote and bleak and continuation of the criminal case would put the accused to great oppression and prejudice and extreme injustice would be caused to him by not quashing the criminal case despite full and complete settlement and compromise with the victim. In other words, the High Court must consider whether it would be unfair or contrary to the interest of justice to continue with the criminal proceeding or continuation of the



criminal proceeding would tantamount to abuse of process of law despite settlement and compromise between the victim and the wrongdoer and whether to secure the ends of justice, it is appropriate that criminal case is put to an end and if the answer to the above question(s) is in the affirmative, the High Court shall be well within its jurisdiction to quash the criminal proceeding.”

11. Although present case pertains to an offence under Section 326 IPC yet good sense prevailed upon the parties and they have settled the dispute and this Court accepts the settlement just to enhance the spirit of brotherhood, peace and harmony between the parties and to improve their relationship in future.

12. Applying the law settled by Hon'ble Supreme Court in plethora of judgments and this High Court it is apparent that when the parties have entered into a compromise, in the nature of cases as prescribed then continuation of the proceedings would be merely an abuse of process of the Court and by allowing and accepting the prayer of the petitioners by quashing the FIR would be securing the ends of justice, which is primarily the object of the legislature enacting under Section 482 Cr.P.C.

13. In the facts and circumstances, this Court finds that the case in hand squarely falls within the ambit and parameters settled by judicial precedents and hence, DDR No. 027 dated 06.05.2021 (Annexure P-1) in FIR No.161, dated 04.05.2021 registered under Sections 323, 324, 326, 452 and 148 read with Section 149 of IPC, at Police Station Ajnala, District Amritsar (Rural) and all the subsequent proceedings arising therefrom, are hereby quashed *qua* the petitioners, on the basis of compromise Annexure P-3.

14. Needless to say that the parties shall remain bound by the terms and conditions of the compromise and their statements recorded before the

Court below. Petition stands allowed.
