SANDEEP MOUDGIL, J (ORAL)

The jurisdiction of this Court has been invoked under Articles 226 of the Constitution of India for directing the official respondents no. 1 to 3 to protect the life and liberty of the petitioners from the hands of respondent nos.4 to 9.

Learned State counsel submits that a speaking order dated 29.05.2025 has been passed on the representation submitted by the petitioners. A copy of the same has been supplied to the counsel for the petitioners. The relevant part of the order read as under:-

“The above writ petitioner Jagpreet son of Malkit Ram, resident of VPO Alla Ditta Police Station Sultanpur Lodhi Distt, Kapurthala, was filed with Petition regarding his marriage to Harsmiranjit, age 25, daughter of Satpal, resident of Village Seham Police Station Sadar nakodhar Distt jalandhar and threats from the family of the girl Harsimranjit. ASI Puran Chand No 397/Kpt. reached the residential address of the petitioner, Village Alla ditta to pursue it. However, since the petitioner's House is Locked Petitioner was not available In

Village inquiries were made about the petitioner Jagpreet from Bakhsish Singh His Cousne Brother son of Mohan Lal, resident of VPO Alla Ditta Police Station Sultanpur Lodhi Distt, Kapurthala,, who stated in his statement that Jagpreet son of Malkit Ram, resident of VPO Alla Ditta He Got Marriage Harsmiranjit, age 25, daughter of Satpal, resident of Village Seham Police Station Sadar nakodhar Distt jalandhar own wishes. But all family member Lock our House. and went to unknow Place. Statements Were Recorded Of The father Of Harsmiranjit Respondent Satpal S/o Boota, Satto W/o Satpal (mother Of Harsmiranjit Kaur) Sunny S/o Satpal (Brother Of Harsmiranjit And Pardeep Singh @ Happy Khalasa S/o Sucha Singh All Resident Of Village Seham Police Station Sadar Nakodhar Distt jalandhar. They Stated In Their statements That have No objection To The marriage above said Petitioners.

The phone numbers of the petitioner Jagpreet 77174-92664 but Not contacted (Switch Off) but no information could be found about the petitioner and new address. However, if any information is found about the petitioner Jagpreet in the future, the Hon'able Court will be informed. with Regard sir. ”

Faced with the situation, learned counsel for the petitioners prays for withdrawal of the present petition.

Prayer is accepted.

Dismissed as withdrawn.

However, the petitioners would be at liberty to avail alternate remedy by way of appeal as per notification No.HOME-HM-40 40SECM/14/2025-2H4/63 dated 23.01.2025 issued by the Department of Home Affairs, Punjab, Government of Punjab (Home-4 Branch).
