The petitioner has filed the instant petition under Section 482 of the BNSS, 2023 for grant of pre-arrest bail to the petitioner in case FIR No. 26 dated 03.04.2025 (Annexure P-1), registered under Sections under Sections 331(6), 115(2), 132, 351(3), 221, 326(g), 191(3), 190 of BNS, 2023 at Police Station Sangat, District Bathinda.

Learned counsel for the petitioner *inter alia* contends that pursuant to the order dated 05.06.2025 passed by this Court, the petitioner has joined investigation and is no longer required for investigation of the case.

Learned State counsel on instruction from concerned Police officials, corroborates the said averment and submits that the custodial interrogation of the petitioner is not required for the purpose of investigation.
