Challenge raised in present writ petition is to the order dated 27.06.2025 (Annexure P-5) passed by respondent No.2 whereby the order dated 25.06.2025 (Annexure P-2) has been withdrawn, alleging the same to be illegal, unjust, unfair, unconstitutional and against the instructions/policy dated 06.10.2004 (Annexure P-7).

Learned counsel appearing on behalf of the petitioner(s) contends that even though the order of transfer of the petitioner from Civil Dispensary, Sector 8, Panchkula to District Civil Hospital, Panchkula (Annexure P-2) dated

25.06.2025 has been cancelled, however, the Medical Officer, Civil Dispensary, Sector 8, Panchkula, is not allowing the petitioner to join on the ground that there is no order of transferring back the petitioner to Civil Dispensary, Sector 8, Panchkula.

Notice of motion to respondents No.1 and 2 only at this stage.

Mr. Vikrant Pamboo, Addl. A.G. Haryana, accepts notice on behalf of the aforesaid respondents and submits that since the order of transfer of petitioner from Civil Dispensary, Sector 8, Panchkula to District Civil Hospital, Panchkula (Annexure P-2) dated 25.06.2025 has been cancelled, hence, there would be no impediment in the petitioner re-joining at her original place of posting wherefrom she was transferred vide the order of transfer which has since then been cancelled.

In view of above, the present writ petition is disposed of as not pressed.

Needless to mention that the petitioner shall appear before the Principal Medical Officer/SMO posted at Civil Dispensary, Sector 8, Panchkula today afternoon and shall be permitted to join.

A copy of the order be given to the counsel for the petitioner under the signatures of Bench Secretary.
