SANDEEP MOUDGIL, J (ORAL)

The jurisdiction of this Court has been invoked under Article 226 of the Constitution of India for directing the official respondents nos.2 and 3 to protect the life and liberty of the petitioners at the hands of respondent no.4 to 7.

Learned State counsel submits that a speaking order dated 06.07.2025 has been passed on the representation submitted by the petitioners. A copy of the same has been supplied to the counsel for the petitioners. The relevant part of the order read as under:-

“Whereas Shemsher singh s/o Dilbag Singh r/o Dolonagal PS Beas District Amritsar & Sandeep Kaur D/o Jaswant Singh w/o Shemsher singh r/o Bhangwan PS Jandiala Distt ASR had moved a writ Petition bearing number CRWP-7109-2025 before the SSP ASR-R. The Petitioners have mentioned in their petition that they both are majors and they both are living happily their married life against the wishes of petition no.2 Parents Jaswant singh s/o Bhan Singh, Balwinder Kaur, Gurpreet singh s/o Jaswant singh And Simranjeet kaur w/o Gurwinder singh All r/o Bhangwan PS Jandiala now they are apprehending danger to their lives at the hands of above mentioned respondents in the writ petition and demanded protection of their life and liberty.

During the enquiry of Petitioners Shemsher singh s/o Dilbag Singh r/o Dolonagal PS Beas District Amritsar & Sandeep Kaur D/o Jaswant Singh R/o Bhagwan PS Jandiala District Amritsar, ASI Shemsher Singh Visited the village Dolonagal PS Beas However Petitioners Were not Found Living in the Village Dolonagal ASI Shemsher Singh took the Statement of the Parents of Petitioners and Village Dolonagal Panchayat Submit Panchayatnama in which it is Written that the parents of Petitioner Shemsher singh who left home without telling on date 28-06- 2025 no one has found him yet his phone is also switched off.we have also given complaint on date 30-05-2025 to the police station and till now the shemsher singh has nol come back to our home. have no objection with their married life and they are not evan interested where they live and what they do.

Keeping in view the abovementioned facts, for the time being no further action is required on this petition and this petition Will be filed to record room after Police Comes in Contact With the Petitioners and their Police protection will be ensured in case of dissatisfaction. with these speaking orders, Petitioners can file appeal against these orders. ”

In the light of above, learned counsel for the petitioners prays for withdrawal of the present petition.

Prayer is accepted.

However, the petitioners would be at liberty to avail alternate remedy by way of appeal as per notification No.HOME-HM-40 40SECM/14/2025-2H4/63 dated 23.01.2025 issued by the Department of Home Affairs, Punjab, Government of Punjab (Home-4 Branch).

Dismissed as withdrawn.
