Status report by way of affidavit of Harish Behal, PPS, Deputy Superintendent of Police, NDPS, Batala has been filed on behalf of respondents No.1 to 3 and the same is taken on record.

As per the status report, case FIR No.77 dated 04.06.2025, under Sections 109, 221, 121(1), 122(2), 132, 3(5) of BNS, Police Station Qadian, Tehsil Batala, District Gurdaspur has been registered against Sawinder Singh @ Bau son of Balwant Singh and his son Anaj Singh @ Nikka. On 03.06.2025, in connection with FIR No.75 dated 01.06.2025, under Sections 21, 29-61-85 of NDPS Act, registered at Police Station Qadian, police got the information that Sawinder Singh @ Bau would be apprehended, if a raid is conducted at his house. Police Party reached at village Muradpur and raided the house of accused Sawinder Singh @ Bau.

Sawinder Singh @ Bau and his younger son went to the roof of their house with Gandasi in their hands. They had already kept sharp weapons and bricks on the roof of the house. When LR/ ASI Avtar Singh No.1716/BTL started climbing up to arrest him, Sawinder Singh @ Bau attacked with Gandasi on his head with the intention to kill him. He raised his right hand to defend himself and a direct blow from the Gandasi hit his right hand. Son of Sawinder Singh @ Bau picked up a stone and hit LR/ASI Avtar Singh No.1716/BTL with the intention to kill him, which hit on his right leg and the accused persons obstructed the police officials from performing their duty. Thereafter, accused Sawinder Singh @ Bau surrendered before the trial Court and got recovered the Gandasi used in the offence. Accused Anaj Singh @ Nikka son of Swinder Singh have been arrested on 30.06.2025. It has been submitted that the local police of Police Station Qadian was raiding the house of the petitioner only to arrest her son Sawinder Singh @ Bau, who is accused in FIR No.75 dated 01.06.2025, under Sections 21, 29-61-85 of NDPS Act, registered at Police Station Qadian, who is real son of the petitioner. Details of 10 more cases have been given in the status report, which are pending against the son of the petitioner.

So, keeping in view the aforesaid report, no further order is required to be passed.

Present petition stands disposed of accordingly.
