In the present writ petition, the petitioner is praying for quashing of show cause notices dated 07.03.2018 (Annexure P-1), 07.03.2018 (Annexure P-2), 18.10.2021 (Annexure P-3) & 08.12.2022 (Annexure P-4) and impugned charge-sheet dated 22.07.2022 (Annexure P-5) issued to the petitioner by respondent No.3.

2. Learned counsel for the petitioner submits that the issue involved in the present writ petition is duly covered by the judgment passed

by a co-ordinate Bench of this Court in case titled as Punjab State Warehousing Corporation Field Employees Union versus Union of India and others, CWP No.27725 of 2013 and other connected petitions, decided on 14.05.2025.
