The present petition has been filed under Section 483 of Bharatiya
Nagarik Suraksha Sanhita, 2023 seeking interim bail to the petitioner in case
bearing FIR No.522 dated 19.10.2023 under Sections 22(C)/29 of the NDPS
Act registered at Police Station City Bhiwani, District Bhiwani, Haryana.

On 16.07.2025, the following order was passed:-

*'Prayer in the present petition filed under Section 483 of the
Bharatiya Nagarik Suraksha Sanhita, 2023 is for grant of interim
bail to the petitioner for taking care of his wife and for her
treatment, as she is suffering from 3rd stage cancer, in FIR No.522
dated 19.10.2023 under Sections 22(c) & 29 of the Narcotic Drugs
and Psychotropic Substances Act, 1985, registered at Police Station
City Bhiwani, District Bhiwani.*

*Learned counsel for the petitioner, inter alia, contends that
wife of the petitioner is taking treatment from the Department of
Medical Oncology NCI, All India Institute of Medical Sciences, New
Delhi, National Cancer Institute, Jhajjar, as she is suffering from 3rd
stage cancer and her chemotherapy is scheduled for 22.08.2025.
Further, there is no other member in the family of the petitioner to
arrange the funds and provide support to his wife.*

Notice of motion.

*Ms. Geeta Sharma, DAG, Haryana, who is present in the
Court, accepts notice on behalf of the respondent-State. She is
directed to file the status report, after verifying the medical record
attached with the present petition with regard to treatment taken by
wife of the petitioner and schedule of chemotherapy required by her.*

In compliance thereof, the learned State counsel has filed a verification report in the Court today and the same is taken on record.

The Superintendent of Jail, District Jail, Bhiwani, got the verification of the medical record of the wife of the petitioner from a Station House Officer, Police Station City Bhiwani and during verification, it was found that she is suffering from a disease, namely, Carcinoma Ovary which is at Stage-III and she has already received 06 cycles of chemotherapy and her chemotherapy is required to be continued till the disease is under control and she requires frequent visits to hospital.

Keeping in view the health condition of the wife of the petitioner and the verification done by the jail authorities, the present petition is allowed and the petitioner is ordered to be released on interim bail for a period of 30 days from 16.08.2025, on his furnishing bail bonds/surety bonds to the satisfaction of Illaqa Magistrate/Trial Court and the petitioner is directed to surrender before the jail authorities on 15.09.2025 by 05:00 P.M.
