1. On the last date of hearing, following order was passed:-

“Learned counsel for the petitioner submits that the claim of the petitioner is covered by the judgment of the Coordinate Bench of this Court in Civil Writ Petition No.2458 of 2013 titled as M/s Shahi Export House (presently Shahi Exports Pvt. Ltd), Faridabad vs. Presiding Officer, Industrial Tribunal-cum-Labour Court Circle-1, Faridabad and another, decided on 23.04.2015.

No one has appeared on behalf of respondent No.2.

In the interest of justice, adjourned to 01.08.2025.

Learned counsel for the petitioner submits that the issue raised in the present petition has already been answered by the Co-ordinate Bench of this Court while passing order in ***CWP No.2458 of 2013 titled “M/s Shahi Export House (presently Shahi Exports Pvt. Ltd.), Faridabad Vs. Presiding Officer, Industrial Tribunal-cum-Labour Court, Circle-1, Faridabad and anr.”, decided on 23.04.2015***, wherein, the award was set aside and the case was remanded back to the Labour Court to decide the lis between the parties afresh.

4. The present petition is also disposed of in terms of order passed in ***CWP No.2458 of 2013 titled “M/s Shahi Export House (presently Shahi Exports Pvt. Ltd.), Faridabad Vs. Presiding Officer, Industrial Tribunal-cum-Labour Court, Circle-1, Faridabad and anr.”, decided on 23.04.2015***.
