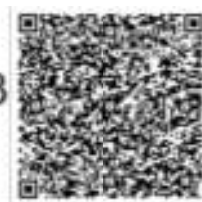

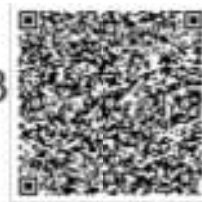

The prayer in the present petition under Section 528 BNSS, 2023 is for the issuance of an appropriate order or direction to respondent No.2 to conduct proper and fair investigation of case FIR No.41 dated 02.04.2025 under Section 109(1), 126, 3(5) of BNS and Section 25(1-A) of the Arms Act, registered at Police Station Alewa, District Jind or to depute some high rank police official not below the rank of IPS for conducting the investigation of the present case.

2. On 21.07.2025, the following order was passed:-

3. On 02.09.2025, the following order was passed:-

The Counsel for the State has filed affidavit of Mr. Sajay Kumar, HPS, Deputy Superintendent of Police, Uchana, District Jind in the court today, which is taken on record.

The petitioner shall appear before the Director PGIMS Rohtak who is directed to constitute a Board of Doctors to examine the petitioner on 05.09.2025 at 11.00 am in PGIMS, Rohtak and submit a report to this Court as also to the investigating agency about the nature of injuries suffered by the petitioner.

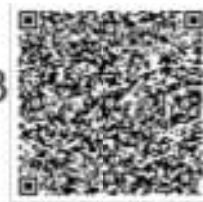
The SHO Police Station Alewa, District Jind shall inform the petitioner and ensure his presence at PGIMS, Rohtak on date fixed for his examination i.e. 05.09.2025.

A copy of this order be sent to the office of Director PGIMS, Rohtak for necessary compliance.

Adjourned to 12.09.2025.

4. A perusal of the affidavit dated 28.08.2025 filed by the DSP, Uchana, District Jind, would reveal that the investigation has been conducted and it has been conclusively found that respondents No.4 and 5 were not present at the spot and were present elsewhere. Further, it has also been found that the petitioner had suffered gun-shot injuries for which the instant FIR already stands registered.
