This Criminal Writ Petition under Article 226 for issuance of writ in the nature of mandamus for issuance of direction to official respondents to protect the life and liberty of the petitioners and to restrain the private respondents not to harass the petitioners.

Learned State Counsel has submitted that a speaking order has already been passed in the representation dated 16.07.2025 (Annexure P-5 and P-6) by the authorities concerned and has produced the copy of the same, which is taken on record. He has furnished a copy of the order to counsel for the petitioners. The relevant part of the speaking order is reproduced below :-

‘Whereas Harjit Kaur w/o Gurwinder Singh d/o Ratan Singh R/o Ward no 8 Bhabat PS Zirakpur District S.A.S. Nagar currently residing at H.No 114 Sector 14 Dadu Majra, Chandigarh & Gurwinder Singh s/o Vijay Kumar R/o Hino 114 Sector 14 Dadu Majra Chandigarh had moved a complaint bearing number 5903/5/5SP date 21-07-2025 before the Senior Superintendent of Police Distt. S.A.S Nagar. The petitioners are major and fully competent to take the important decisions at their own. They both fell in love with each other and wanted to perform the marriage. But her father Ratan Singh s/o Aatam Singh, mother Manjeet Kaur w/o Ratan Singh, brother Harinder Singh all resident of Wardino 08 S.A S. Nagar and Ranjit Singh r/o Hino 2919. sector 128, Sunny Enclave Mohalli are harassing and giving life threats to them. The complainant Is now seeking protection of life and liberty)

It is found that complainants are major, Harjit Kaur's date of birth is 18-11-1992 and Gurwinder Singh's date of birth is 29-11-1994. They both are known to each other for many years. To enquire the matter ASI Rajeev Kumar went to ward no 8 Bhabat PS Zirakpur District S.A.S. Nagar but because of large area and compact population, both the petitioners and respondents no 4 to 7 are not traceable. The mobile number of petitioners 99146-65527 is also switched off. In relation to this DDR no 42 date 21-07-2025 is registered. As per the complaint, present address of petitioners H.no 114 Sector 14, Dadu Majra Chanidgarh is not fall under the Jurisdiction of PS Zirakpur. She also filed petition no CRWP-7833-2025 before the Hon'ble High Court seeking protection of her life.

Keeping in view the abovementioned facts, no further action could be taken in this complaint and this complaint is being filled to the record room and the information will be sent to concerned police station of Hino 114 Sector 14, Dadu Majra Chanidgarh.’

In light of the above, counsel for the petitioner does not wish to press this petition further.

The petitioners would be at liberty to file appeal, as is stipulated in the Standard Operating Procedure, in the light of notification No.HOMEHM-40 40SECM/14/2025-2H4/63 dated 23.01.2025 issued by the Department of Home Affairs, Punjab, Government of Punjab (Home-4 Branch), in case of any grievance left after passing of the speaking order.

Petition stands dismissed as not pressed.
