Prayer in the instant petition filed under Article 226/227 of the Constitution of India, is for issuance of directions to respondents No.1 to 3 to provide protection of life and liberty to the petitioners, who are in live-in-relationship against the wishes of private respondents No.4 to 11.

Learned counsel for the petitioners submits that both the petitioners are major, petitioner No.1 – Kamalpreet Kaur, aged 26 years and petitioner No.2 – Saru Khan, aged 27 years and are in live in relationship with each other. Learned counsel for the petitioners further submits that the first marriage of petitioner No.1 was solemnized with respondent No.4 and on account of atrocities committed upon her by respondent No.4, she left that matrimonial house and there is no issue from the said marriage and since then she is in live in relationship with petitioner No.2. They apprehend danger from respondent No.4. Hence, they are seeking protection in that regard and have approached this Court by way of filing the instant petition.

The copies of Aadhaar cards of petitioners (Annexures P-1 and P-2) have been placed on record.

Learned counsel for the petitioners has relied upon a judgment of this Court in CWP No.31834 of 2019 titled as “Megha and another vs. State of Haryana and others” decided on 04.11.2019 and submitted that this Court had entertained petition for protection of couples in live-in relationship.

Notice of motion.

On the asking of the Court Ms. Gagandeep Kaur, DAG, Punjab accepts notice on behalf of the respondents-State.

At this stage, without expressing any opinion on the merits of the case as well as nature of relationship between the petitioners, the petition is disposed of with a direction to respondent No.2 to look into the representation dated 15.07.2025 (Annexure P-3) at the earliest, regarding threat perception and take necessary steps, if any required, in accordance with law, to ensure that the life and liberty of the petitioners is not jeopardized at the hands of the private respondents. However, this direction will have no effect on any civil or criminal action, which could be initiated in the matter in accordance with law.
