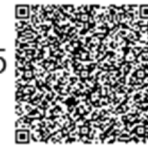

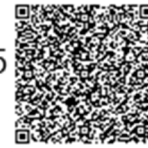

Prayer made in the instant writ petition is to quash the office Order No.37 dated 06.07.2018 (Annexure P-2) to the extent whereby the actual benefit has been restricted and only notional benefit has been granted. A further prayer has been made for directing the respondents to grant Ist ACP Scale and 2nd ACP Scale on completion of 10 years of service on 1.10.2013 and 16 years of service on 01.10.2019, respectively.

2 After arguing the matter at some length, learned counsel for the petitioner submits that the similar controversy has already been decided by this Court in the matter of **Pawan Kumar and Ors. vs. State of Haryana and Ors, CWP No.5752 of 2020 decided on 21.04.2025.** Learned counsel for the petitioner submits that with regard to the grievance, the petitioner has already submitted a legal notice dated 01.05.2025 (Annexure P-4) but the respondents have not taken any action thereupon till date. He contends that the petitioner would be satisfied at this stage, in case respondent No.2- The Principal Chief Conservator of Forest, Forest Department, Haryana, Panchkula, is directed to consider and decide the aforesaid legal notice by passing a reasoned and speaking order in a time bound manner.

3 Notice of motion.

4 Dr.(Ms.) Malvika Singh, DAG, Haryana, accepts notice on behalf of the respondents and she has no objection to the aforesaid prayer being granted.

5 Accordingly, the present petition is disposed of with the consent of the parties and without commenting anything on the merits of the case, by directing respondent No.2-The Principal Chief Conservator of Forest, Forest Department, Haryana, Panchkula, to consider and decide the legal notice dated 01.05.2025 (Annexure P-4) in light of the judgment passed by this Court in **Pawan Kumar and Ors (supra)** by passing a reasoned and speaking
