**CM-12869-C-2024**

Prayer in this application preferred under Section 151 CPC is for placing on record joint affidavit dated 15.12.2024 stating about a compromise having been arrived at between the parties.

For the reasons mentioned in the application, the same is allowed and the joint affidavit dated 15.12.2024 is taken on record.

**CM-12870-C-2024**

Prayer in the present application is for bringing on record the legal representatives of respondent No.5-Naro Devi. It has been stated in the application that Naro Devi expired on 04.01.2024 leaving behind the legal representatives mentioned in para 2. It has also been averred that apart from the legal representatives mentioned in para 2, there are no other legal



representatives of Naro Devi.

For the reasons mentioned in the application, the same is allowed subject to all just exceptions.

Legal representatives mentioned in para 2 of the application are ordered to be brought on record. Amended memorandum of parties is taken on record. The Registry is directed to tag the same at an appropriate place in the file.

1. Learned counsel for the parties are *ad idem* that the matter between the parties has been amicably settled in terms of the compromise deed dated 23.09.2024 (Annexure A-1).
2. Learned counsel for the parties are further *ad idem* that all parties to the *lis* are signatories to the said compromise and that under the circumstances, the present Regular Second Appeal be disposed of in terms of the said compromise dated 23.09.2024 and the document be made a part of the decree.
3. In view of the statement given by learned counsel for the parties, the present Regular Second Appeal is ***disposed of*** in terms of the compromise. The compromise deed dated 23.09.2024 (Annexure A-1) as also the affidavit dated 15.12.2024 which has been taken on record today be made a part of the decree.
