The petitioner has filed the present petition under Section 482 of B.N.S.S with a prayer to grant anticipatory bail to him in case bearing FIR No.175 dated 27.06.2025 under Sections 115(2), 118(1), 3(5), 324(4), 351(2) of the Bharatiya Nyaya Sanhita, 2023 (for short 'BNS'), registered at Police Station Mullana, District Ambala.

Learned counsel for the petitioner *inter alia* contends that pursuant to the order dated 01.08.2025 passed by this Court, the petitioner has joined investigation and is no longer required for investigation of the case.

Learned State counsel on instruction from the investigating officer, corroborates the said averment and submits that the custodial interrogation of the petitioner is not required for the purpose of investigation.

Heard learned counsel for the parties.

Since the petitioner has joined the investigation and his custodial
