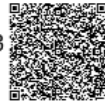

SUDEEPTI SHARMA, J. (Oral)

1. With the consent of learned counsel for the parties, 8 civil original contempt petitions shall stand disposed of by this common order (details whereof are given at the header of the order).

2. The contempt petitions have been filed for deliberate and intentional disobedience of order dated 17.12.2024, passed by this Court.

3. On asking of the Court, Mr. Animesh Sharma, Additional Advocate General, Punjab accepts notice on behalf of State and contends that in compliance of order dated 17.12.2024, speaking order dated 28.02.2025, has been passed. Copy of the same has been supplied to learned



counsel for the petitioners and also placed on record. This fact is not disputed by the learned counsel for the petitioners.

4. A perusal of speaking order dated 28.02.2025, shows that order dated 17.12.2024, passed by this Court, has been complied with.

5. In view of the above, all the civil original contempt petitions are disposed of. The contempt is purged and rule is discharged.
