(ii) In view of the averments made in the applications, coupled with the fact that the parties have amicably settled the matter, the applications are allowed. The date of hearing in the aforesaid appeals is advanced from 13.11.2025 to today itself. The main appeals shall be taken up before the Board.

1. Keeping in view the compromise dated 22.05.2025 (Annexure A-1) arrived at between the parties, copies of which have been appended as Annexure A-1 to both the appeals, this is a fit case to exercise the power conferred under Order XXIII Rule 3 of the Code of Civil Procedure, 1908.
2. Accordingly, the present Regular Second Appeals are disposed of in terms of the said compromise. The compromise dated 22.05.2025 (Annexure A-1) shall form part of the decree.
3. Needless to say that the parties shall remain bound by the terms and conditions of the compromise. In the event of any party failing to comply with the terms thereof or resiling therefrom, the other party shall be at liberty to proceed against such party in accordance with law.
4. Pending miscellaneous application(s), if any, shall also stand disposed of.
