1. This petition under Section 528 of Bharatiya Nagarik Suraksha Sanhita has been filed seeking directions to respondent Nos.1 to 5 to conduct fair and impartial investigation in case FIR No.66 dated 20.04.2024 under Section 306 of IPC registered at Police Station Civil Lines, Police Commissionerate Amritsar, by constituting a Special Investigation Team.

2. On 26.09.2024, the following order was passed :

“This petition under Section 528 of Bharatiya Nagarik Suraksha Sanhita has been filed seeking directions to respondents No.1 to 5 to conduct fair and impartial investigation in case FIR No.66 dated 20.04.2024 under Section 306 of IPC registered at Police Station Civil Lines, Police Commissionerate Amritsar, by constituting a Special Investigation Team.

2. *Learned counsel for the petitioner submits that on 08.04.2024, an information regarding the commission of suicide by Gurpreet Singh, who is the brother of petitioner was received. It has been stated that suicide was committed on 06.04.2024. He also submits that as per the CCTV footage on 06.04.2024, the*



deceased was alive and the police is not taking into consideration the CCTV footage of the place of occurrence.

- 3. *Notice of motion.*
- 4. *At asking of Court, Mr. Vinay Kumar, DAG, Punjab, who is present in Court, accepts notice on behalf of respondents(State).*
- 5. *Commissioner of Police, Amritsar-respondent No.4 is directed to look into the matter and file a detailed status report in this regard.*
- 6. *List on 04.10.2024.”*

3. In compliance thereof, status report by way of affidavit dated 03.10.2024 of Commissioner of Police, Amritsar on behalf of respondent Nos.1, 2, 4 and 5 was filed. Learned State counsel refers to para 5 at page No.8 of the status report and submits that a Special Investigation Team has been constituted to take the investigation of the case, to a logical conclusion and the final report would be filed before the jurisdictional Court upon conclusion of the investigation.

4. In view of the above, no further directions are required to be passed in the present petition and the same stands disposed of accordingly.

5. However, the Special Investigation Team is directed to involve the petitioner and record her statement during investigation.
