HARSIMRAN SINGH SETHI J. (ORAL)

1. By this common order above mentioned LPAs are being disposed of as common question of law and facts are involved.
2. Learned counsel for the parties submit that though, there is a dispute with regard to the maintainability of the revision before the Government, as directed to be availed by the learned Single Judge, all the parties are agreeable that the impugned order dated 23.10.2024 passed by the learned Single Judge be set aside and the writ petitions are remanded back to be decided on the merits rather than sending the appellant herein to avail the remedy of revision by keeping the question of law open.
3. Accordingly, as prayed by the parties to the litigation, the order passed by the learned Single Judge is set aside. The cases are remanded back to the learned Single Judge to be decided on merits keeping in view the joint agreement between the parties. Question of law qua maintainability of revision before the Government is kept open.
4. Pending application(s), if any, stands disposed of.
