1. Petitioner Amandeep has filed petition under Section 482 of Bharatiya Nagarik Suraksha Sanhita, 2023 for grant of pre-arrest bail in case FIR No. 213 dated 02.08.2024 under Section 333, 115(2), 118, 3(5), 76, 351(2) of Bharatiya Nyaya Sanhita, 2023 registered at Police Station Phillaur, Jalandhar (Annexure P/1).

2. As per the facts of case Gagandeep Mander gave his statement that he is Auto Rickshaw driver. On 29.07.2024 at about 05:00 PM, he was coming home from his work and when he reached the house of Satnam Singh, many motorcycles were parked there and while passing in front of the house of Kohinoor alias Sathi Satnam, his Auto Rickshaw collided with one of the motorcycle. He stopped his Auto Rickshaw and get motorcycle on one side. In the meantime, Kohinoor alias Sathi Satnam came outside raising *lalkara*. He ran away and came to his house. Kohinoor alias Sathi



Satnam armed with *Datar* came to his house and hit on the back of his head. Kamalpreet alias Billa armed with Cane also entered his house and gave blow on his left bicep and another blow on left shoulder and right thigh. Aman also entered his house and gave stick blow which hit on his right ankle and other blows on his thigh, waist and left leg. He raised an alarm. His father Joga Singh tried to rescue him and he was also beaten up by Jita. Thereafter, his mother Manjit Kaur also came forward to save them. Sushil Kumar Verma gave three stick blows on her left hand and right knee. His sister 'S' also tried to rescue them, on this Kohinoor alias Sathi outraged her modesty and she was thrown on the ground. He ran to the house of his neighbour to save himself. Other co-accused Ajay Kumar, Shilu, Gopi and two other boys followed him with their respective weapons. Main door of his house was damaged. Thereafter, assailants left the spot raising *lalkaras*.

3. Learned counsel for petitioner argued that he was granted *interim* bail vide order dated 22.10.2024 and in pursuance of this order, he has already joined investigation. He is still ready to abide by terms and conditions of bail order. Therefore, his anticipatory bail petition may be allowed.

4. Status report has been filed. It is confirmed that in pursuance of order passed by this Court, petitioner has joined investigation. Today, it is further confirmed that alleged weapon of offence is also handed over to police. Therefore, petitioner is not required for any other purpose.

5. Considering the aforesaid factual position, no purpose would be served by sending the petitioner behind the bars. He has already joined investigation and fully cooperated. Therefore, without expressing my mind on the merits of case, present petition filed by petitioner Amandeep is allowed and *interim* bail already granted in his favour vide order dated 22.10.2024 stands confirmed, subject to terms and conditions as enshrined under Section 482(2) of Bharatiya Nagarik Suraksha Sanhita, 2023.

6. Pending application(s), if any, also stands disposed of accordingly.
