SHEEL NAGU, CHIEF JUSTICE, (ORAL)

1. None has appeared on behalf of the petitioner. Even on the earlier occasion i.e. 20.03.2025, none had appeared on his behalf.

2. In pursuant to the order of preventive detention passed against the petitioner, he was lodged at Dibrugarh Central Jail, Assam.

3. It is informed by Mr. Anupam Gupta, learned senior counsel appearing for the State of Punjab that period of detention under the preventive detention order, expired on 19.03.2025. Thereafter, the petitioner was arrested in connection with offence arising from attack at Police Station Ajanala, Amritsar vide FIR No.39 of 24.02.2023, Police Station Ajnala,

Amritsar (Rural) was registered against him and he has now been lodged in Central Jail, Patiala.

3. The prayer made in this petition was for the transfer of the petitioner from Dibrugarh Central Jail, Assam to some other safe place, which in view of the aforesaid subsequent events that have taken place during the pendency of this petition, appears to have been duly satisfied.

4. In view of above, the cause raised herein has become infructuous and the petition is dismissed as having been rendered infructuous.
