1. The petitioner has filed the instant petition under Section 483 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking quashing of FIR No.14 dated 29.01.2025 registered under Sections 137(2), 87 & 64 of Bharatiya Nyaya Sanhita, 2023 and Sections 3, 4 & 6 of Protection of Children from Sexual Offence Act, 2012 (Sections 17 & 21 of POCSO Act, 2012) at Police Station Goraya, District Jalandhar.
2. In para 19 of the petition, it has been stated that the petitioner is not involved in any other criminal case nor any other FIR is pending against him anywhere in India.
3. Learned State counsel has produced custody certificate dated 30.09.2025 which is taken on record. As per the custody certificate, the petitioner is involved in the following 09 other cases :-
