This petition has been filed under Section 528 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking quashing of FIR No.0005 dated 04.01.2022 under Sections 279, 337 and 338 of IPC, 1860 registered at Police Station Model Town, Panipat, District Panipat (Annexure P-1) along with all subsequent proceedings arising therefrom on the basis of compromise dated 19.09.2025 (Annexures P-5).

2. A Coordinate Bench of this Court vide order dated 14.10.2025 had directed the parties to appear before the trial Court to get their statements recorded and the learned Magistrate/trial Court was directed to send its report qua the genuineness of the compromise.

3. Pursuant to the aforesaid order, parties have appeared before the learned Judicial Magistrate Ist Class, Panipat and got their statements recorded. On the basis of the statements so recorded, learned trial Court has submitted the report bearing endorsement No.961 dated 20.10.2025 to the effect that the compromise has been effected between the parties voluntarily and without any coercion or undue influence.

4. Learned State counsel as well as counsel for respondents No.2 to 4 have not disputed the factum of compromise between the parties.

5. In view of the above, no useful purpose would be served to continue with the proceedings before the trial Court in the instant FIR.

6. Following the principles laid down by the Full Bench judgment of this Court in **Kulwinder Singh and others Versus State of Punjab and another 2007 (3) RCR (Criminal) 1052** and approved by the Hon'ble Supreme Court in **Gian Singh Versus State of Punjab and others (2012) 10 SCC 303**, this petition is allowed and FIR No.0005 dated 04.01.2022 under Sections 279, 337 and 338 of IPC, 1860 registered at Police Station Model Town, Panipat, District Panipat (Annexure P-1) along with all subsequent proceedings arising therefrom are quashed qua the petitioners on the basis of compromise dated 19.09.2025 (Annexures P-5).

Other misc. application(s), if any, also stand(s) disposed of accordingly.
