The instant petitions have been filed by the petitioners for directing the respondents to grant the benefits of Pension, GIS, Medical Allowances and leave encashment alongwith all other consequential benefits with interest to the petitioners, who were posted as Craft Teachers.

Counsel for the petitioners contends that similar benefits have already been granted to similarly placed persons/employees and that a representation was submitted by the petitioners also for seeking the abovementioned reliefs.

Learned State Counsel, on the other hand, informs that the judgment of the Single Bench, which has been relied upon by the counsel for the petitioners already stands stayed by the Division Bench of this Court in LPA No.2322 of 2024 and other connected matters.

Under the given circumstances, the present writ petitions are disposed of as not pressed at this stage with liberty to the petitioners to take recourse to the appropriate remedy and to file the petition(s) afresh on the same cause of action after the decision of LPA No.2322 of 2024 and/or other connected matters.
