SUMEET GOEL, J. (Oral)

1. Present petition has been filed under Section 483 of BNSS, 2023 for grant of regular bail to the petitioner in case bearing FIR No.113 dated 24.08.2023, registered for the offences punishable under Sections 21/61/85 and (Section 29 of the NDPS Act and Section 25, 54, 59 of the Arms Act added later on) at Police Station Amargarh District Malerkotla (earlier District Sangrur).

2. The petitioner was extended the concession of interim bail vide order dated 23.05.2025 passed by Coordinate Bench of this Court. This Court does not deem it appropriate to reproduce the same lest it may burden the instant order.

3. Having heard learned counsel for the rival parties and upon perusal of the record, especially keeping in view the factum of the reasons recorded in the order dated 23.05.2025 (whereby the interim bail was extended to the petitioner) as also the petitioner, admittedly, not having



misused the concession of interim regular bail, this Court is inclined to confirm the said order. As per custody certificate dated 24.08.2025 filed by learned State counsel, the petitioner has already suffered incarceration for a period of 01 year, 09 months and 01 day and is stated to be involved in any other case.

Suffice to say, further detention of the petitioner as an undertrial is not warranted in the facts and circumstances of the case.

4. In view of above, the present petition is allowed and interim order dated 23.05.2025 is hereby made absolute. The petitioner is ordered to be released on regular bail on the already furnished bail/surety bonds to the satisfaction of the Ld. concerned Special Court, NDPS Act/Duty Magistrate. However, in addition to conditions that may be imposed by the concerned Special Court, NDPS Act/Duty Magistrate, the petitioner shall remain bound by the following conditions:-

- (i) The petitioner shall not mis-use the liberty granted.
- (ii) The petitioner shall not tamper with any evidence, oral or documentary, during the trial.
- (iii) The petitioner shall not absent himself on any date before the trial.
- (iv) The petitioner shall not commit any offence while on bail.
- (v) The petitioner shall deposit his passport, if any, with the trial Court.
- (vi) The petitioner shall give his cellphone number to the Investigating Officer/SHO of concerned Police Station and shall not change his cell-phone number without prior permission of the trial Court/Illaq Magistrate.



(vii) The petitioner shall not in any manner try to delay the trial.

(viii) The petitioner shall submit, on the first working day of every month, an affidavit, before the concerned Special Judge of NDPS Court, to the effect that he has not been involved in commission of any offence after being released on bail. In case the petitioner is found to be involved in any offence after his being enlarged on bail in the present FIR, on the basis of his affidavit or otherwise, the State is mandated to move, forthwith, for cancellation of his bail which plea, but of course, shall be ratiocinated upon merits thereof.

5. In case of breach of any of the aforesaid conditions and those which may be imposed by concerned Special Court, NDPS Act/Duty Magistrate as directed hereinabove or upon showing any other sufficient cause, the State shall be at liberty to move cancellation of bail of the petitioner.

6. Ordered accordingly.

7. Nothing said hereinabove shall be construed as an expression of opinion on the merits of the case.

8. Since the main case has been decided, pending miscellaneous application, if any, shall also stands disposed off.
