1. Mr. Shaiwal Srivastava, learned counsel for the plaintiffs states that the plaintiffs have amicably settled the matter with defendant nos. 2, 3, and 4, therefore, the cause of action against the said defendants does not survive.

1.1 He states that defendant no. 5 could not be traced and was not even served in the present proceedings, thus, the plaintiffs are abandoning the proceedings against defendant no. 5.

1.2 He states that with respect to defendant no. 1, the plaintiffs have already initiated arbitral proceedings which are pending before the Delhi International Arbitration Centre ('DIAC').

1.3 He states in these facts, the plaintiffs have decided not to pursue these claims any further, without prejudice to the claims which are already pending adjudication before DIAC.

1.4 He states that defendant nos. 6, 7 and 8 were impleaded for a limited purpose of securing compliance of orders and no separate relief is sought
