1. This hearing has been done through hybrid mode.
2. The present appeal has been filed by the Appellant – Devender @ Lala under Section 374(2) of the Code of Criminal Procedure, against the impugned Judgment dated 20th July, 2009 and the impugned Order on Sentence dated 23rd July, 2009, passed by the court of District Judge-VII/NORTH-EAST-CUM-ASJ, Karkardooma Courts, Delhi, in Session Case bearing No. 23/2009 arising out of FIR bearing No. 09/2008, registered under Sections 363/366/376 IPC.
3. The Appellant was convicted and sentenced under Sections 363/366/376 IPC. It is submitted by the Appellant that he was released from the jail, after completing the sentence awarded to him. The same was also affirmed by the learned APP for the State.
4. The Appellant has been identified by SI Sneh, PS – Gokalpuri. The Appellant has submitted that he is not pressing his appeal. After questioning



the Appellant, this Court is satisfied that he is making the statement after knowing the consequences of the same as he has been made aware of the consequences of his statement.
