10. Mr. Gopal Singh, learned counsel accepts notice on behalf of NHAI and on instructions submits that NHAI has no objection to the extension of mandate of the learned Arbitral Tribunal in all the three arbitration cases.

11. It is stated in the petitions that the arbitral proceedings are at the stage of cross-examination of Claimant's witnesses and the mandate extended by this Court vide order dated 27.08.2024 has expired on 23.02.2025.

12. Accordingly, with the consent of the parties, mandate of the learned Arbitral Tribunal is extended by a period of one year from 29.05.2025 and period between 24.02.2025 to 28.05.2025 is regularised and in respect of all the three arbitrations, being subject matter of these three petitions.

13. Petitions are allowed and disposed of in the aforesaid terms.
