2. The prayer clause of the petition is extracted below:

“a) Issue a Writ, Order or Direction of Mandamus directing the Respondent to produce its official record giving the detailed and specific reasons for rejection of the Petitioner’s Technical Bid;

b) Issue a Writ, Order or Direction of Mandamus directing the



*Respondent to fairly evaluate the Technical Bid of the Petitioner;
c) If the reasons given pertained to curable defects or if no substantial reasons are given, direct the Respondent to open the financial bid of the Petitioner;
d) Allow the interim relief by granting stay on the tender process till adjudication of the present Writ Petition;
e) Pass any other Order that this Hon'ble Court deems fit in the interest of justice."*

3. At the outset, learned counsel for respondent accepts notice and produces before us a copy of order dated 11.06.2025, reflecting the reason for rejection of the technical bid submitted by the petitioners. A copy of the document is supplied to learned counsel for petitioners.

4. Learned counsel for petitioners seeks permission to withdraw this petition with liberty to file afresh, challenging the rejection in the light of the communication dated 11.06.2025 conveying the rejection.

5. The petition and the accompanying application are dismissed as withdrawn with liberty as sought.
