These petitions have been filed by the petitioner, challenging the Order dated 15.05.2023 passed by the learned Central Administrative Tribunal, Principal Bench, New Delhi (hereinafter referred to as the, 'Tribunal') in O.A. No.1368/2021, titled *Chandan Singh & Ors. v. Union Public Service Commission & Ors.* [in W.P.(C) 14566/2023], O.A. No. 1406/2021, titled *Naveen Jangid & Ors. v. Union Public Service Commission & Ors.* [in W.P.(C) 14570/2023] and in O.A. No.1394/202, titled *Satish Anand & Ors. v. Union Public Service Commission & Ors.* [in W.P.(C)14573/2023], wherein the learned Tribunal disposed of the said O.A.(s) filed by the respondents herein.
