ORDER

In continuation of order dated 20/05/2025 regarding entering legacy data of the period from. 01/07/24 to 03/05/2025 at hospitals under implementation of three New Criminal Laws, the following further clarifications may be noted:

- 1) Data of currently working doctors will be updated using their MedLEaPR credentials
- 2) In case of resignation/transfer of doctors, MRD Incharge ID should be created on the MedLEaPR portal and their legacy data should be entered using this ID only.
- 3) All physical MLCS/PMRs created before MedLEaPR portal went live (Le.04/05/2025) will be used for legal purposes and the doctors who had originally created them will be responsible for the same.

MS/MDs of all hospitals shall ensure data accuracy and fidelity w.r.t. PMR/MLC and ensure completion of task strictly **by 20.06.2025 positively.**

This issues with the prior approval of Competent Authority.
