1. These petitions have been filed seeking compliance of order dated 15th March 2024 in *W.P.(C) 3900/2024* and order dated 20th May 2024 in *W.P.(C) 7899/2024*, where the Court had passed directions for respondents (*Chief Labour Commissioner, (Central) and the Labour Commissioner, GNCTD*), to decide the representation of the petitioners with a speaking order, after giving an opportunity of being heard, to the parties.
2. Status report has been filed by respondent no. 1.
3. Counsel who is appearing for the Labour Commissioner points out that the compliance has been done and order dated 15th October 2024 has been passed.
4. Said order essentially, directs that the DUSIB being the principal employer and *M/s Prayas JAC Society* being the Sub-Contractor, were operating these isolation centres during the '*COVID period*', in which, the

petitioners were working as, ‘*Caretaker*’, ‘*Caretaker Reliever*’ & ‘*Sweeper*’, for a period of 8 months starting from July 2021 to March 2022, for which, they were paid.

5. The findings of the Labour Commissioner are extracted as under:

5. I have gone through the pleadings & documents lead by parties and material available on records and my findings in the case are as under:

The claimants have claimed that they were working with M/s DUSIB through M/s Prayas JAC Society. Further, they have claimed that they have not been paid the wages for the month of July 2021 to March 2022.

Respondent M/s DUSIB have already stated that the payment of due wags of the workmen/ claimants are subject to the necessary documents regarding to the service of the workmen/ claimants and the same was filed by the M/s Prayas JAC Society. The

Respondent M/s DUSIB received and checked the documents and stated that they are satisfied with the documents submitted during the proceeding dated 23.09.2024, as the facts have been admitted by the Respondent M/s DUSIB, there is no reason to disbelieve the claim of the workmen/claimants, therefore I have no hesitation in holding that the workmen/claimants have worked with the Respondents during the period as mentioned in their claim and has not been paid his earned wages for the period as claimed.

Here it is also pertinent to mention that as per Sub-section 3 & 4 of Section 21 of The Contract Labour Act (Regulation and Abolition), 1970: -

(3) It shall be the duty of the contractor to ensure the disbursement of wages in the presence of the authorized representative of the principal employer.

(4) In case the contractor fails to make payment of wages within the prescribed period or makes short payment, then the principal employer shall be liable to make payment of wages in full or the unpaid balance due, as the case may be, to the contract labour employed by the contractor and recover the amount so paid from the contractor either by deduction from any amount payable to the contractor any contract as a debt payable by the contractor.

Hence in view of above, the claimants are entitled to earned wage for the period mentioned in the Annexure-I from Respondent No. 1 i.e., M/s Delhi Urban Shelter Improvement Board (DUSIB).

6. Accordingly, petitions are disposed of, noting the above.

CONT.CAS(C) 1920/2024

1. This petition has been filed by workers, alleging wilful disobedience of order dated 15th October 2024, passed by the Labour Commissioner, findings are extracted above.

2. The said amounts are still not being paid by DUSIB, Mr. Rishi Kant Singh, Counsel for DUSIB states that they had contracted out the work to *M/s Prayas JAC Society*, and therefore, are not obliged to pay the said amounts.

3. Mr. Rishi Kant Singh, submits, that since the matter was sub-contracted to *M/s Prayas JAC Society*, they are to make the payments and then demand the same from DUSIB, and then, DUSIB will reimburse them.

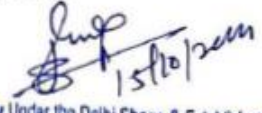

4. The Court is astonished and is completely shocked at this submission which shows sheer insensitivity of the DUSIB to pay these workers, who have worked during the ‘*COVID period*’, to serve the public.

5. The other aspects of the order dated 15th October 2024, to give a background of this matter, are also extracted herein, for the purposes of record:

1. By this order I will dispose of the application/ representation filed by the applicants /claimants Sh. Sanoj Kumar S/o Sh. Siya Ram Mukhiya &13 Ors. dated 29.02.2024 under the Delhi Shops & Establishment Act, 1954 (hereinafter referred to as the Act) regarding non-payment of due earned wages by the respondent/ management.

The claimants have stated in their claim application/representation that they worked with Respondents on post of "Caretaker, Caretaker Reliever & Sweeper full time" for the period of 08 months starting from July 2021 to March 2022 for working in Isolation Center at Geeta Colony during the Covid period employed by the principle employer being DUSIB through sub-contractor M/s Prayas JAC Society Add: 59, Tughlakabad Institutional Area, New Delhi-110062 registered under the Society Registration Act, XXI of 1860 having registration No. S-20291. The claimants have been stated therein representation the respondents have not been paid earned wages till date despite repeated requests have been made. The earned wages / unpaid wages for the period from starting July 2021 to March 2022 totally upto 8 months. Further, stated that the claimants/workmen provided their service in the most difficult and dangerous situation that too during the Covid-19 period. They were working in the DUSIB Board Isolation Center and provided their services in the Isolation Camp at Geeta Colony. During in famous Covid-19 pandemic, which affected the life of every human being on this planet. The Workmen/Claimants were working as Caretaker, Caretaker Reliever & Sweeper full time which required then to have come in contact in contact with the probable Covid-19 positive persons. That owing to the emergent situations the workmen/claimants did not given care to ask for appointment letter or any other documentation and gave their service in those their difficult times. That these Isolation Center were being operated by the DUSIB and the claimants/workmen wherein were thus working for them through the contractor.

These 14 claimants/Workmen worked there for a total period of 10 month i.e. May 2021 to March 2022 during which they give their priceless services and serve a total of 35 patients during the period, for which they were termed as Covid worriers and saviors of humanity, however, these terms proved to be mere words of mouth and were put to shame as these claimants/workmen were not paid for providing their valuable services when everyone else was afraid of given stepping out of their home. Further, the claimants stated that only paid salary for a period of two months and remained unpaid from the month of July 2021 to March 2022. The convivences the list of 14 persons (Annexure – I) who were not paid earned wages the amount to be paid each of them each being reproduced below in a tabular form:

6. The conclusion of the Labour Commissioner passing the order under Delhi Shops and Establishment Act, 1954 reads as under:

7. Therefore, in view of the above, it is held that the workmen/claimants as per Annexure-I, Annexure -II, Annexure -III & Annexure -IV are entitled to receive the amount as mentioned in their respective Annexures on account of payment of earned wages from Respondent No. 1 i.e., M/s Delhi Urban Shelter Improvement Board (DUSIB) for the period as claimed in their respective Annexures. Further, in exercise of powers conferred upon this authority by Sub-Section 3 of Section 21 of the Act, Respondent No. 2 i.e., M/s Prayas JAC Society is hereby directed to pay the workmen/ claimants the penalty/compensation of Rs. 100/- for each workmen/ claimant listed in all the annexures for not making the payment of due earned wages and withholding the same illegally. The Respondent no.1 shall make the payment of earned wages & Respondent No.2 shall make the penalty /compensation to the claimants within 30 days from the date of this order, under intimation to this Authority failing which proceedings to recover the same shall be initiated as per the provisions of Section 21 of the Act.

7. Cousnel for *M/s Prayas JAC Society*, therefore, states that they have paid the penaly compensation of Rs. 100/-, to each workman.

8. In the light of the categorical findings and directions by the Labour Commissioner, it shocks the conscience of this Court, that DUSIB has, instead of coming forth and paying these workers forthwith, has sought to deflect the situation to *M/s Prayas JAC Society*.

In light of this, the Court directs that there shall be complete compliance of these payments, to all the workers, within the next two weeks, failing which, the CEO of DUSIB, respondent no.1/contemnor No.1, shall be present in Court, to show cause as to why they should not be held liable for contempt and sentenced.
10. Compliance ought to have been done before the 13th May 2025, in order that the counsel for petitioner is able to confirm the receipt of payments by the workers, and inform the Court.
11. List on 15th May, 2025.
12. In case of non-compliance, even, with respect to one worker, the CEO of DUSIB shall be present in Court to explain their stand.
