1. Petition under Section 528 of the Bharatiya Nagarik Suraksha Sanhita, 2023 ('BNSS') has been filed on behalf of the Petitioners, for quashing of FIR No.0725/2023 under Sections 498A/406/34 IPC, registered at PS: Okhla Industrial Area, Delhi and all consequential proceedings emanating therefrom, in terms of Settlement Deed dated 21.07.2025.
2. Issue Notice.
3. Learned APP and learned Counsel for the Respondent No. 2 appearing on advance Notice, accept Notice.
4. Brief facts of the case are that the marriage between Petitioner No.1/husband and the Respondent No. 2/wife was solemnized on 24.02.2022, according to the Hindu rites and ceremonies. A female child was born out of the said wedlock on 02.11.2024. Due to temperamental issues, Petitioner No.1/husband and Respondent No. 2/wife are residing separately since 03.04.2023.



5. It is further submitted that on 06.10.2023, on the complaint of Respondent No. 2, FIR No.0725/2023 under Sections 498A/406/34 IPC was registered at PS: Okhla Industrial Area, Delhi.

6. It is submitted that present FIR was a consequence of the matrimonial disputes between Petitioner No.1/husband and Respondent No. 2/wife. It is stated that with the intervention of family members, relatives and well wishers, the Petitioners and Respondent No. 2 have amicably settled all the disputes and differences between them vide Settlement Deed dated 21.07.2025.

7. The parties are present in person in the Court and have been identified by the IO. The parties submit that they have arrived at the settlement without any force, coercion and undue influence and pressure and they have signed the Settlement dated 21.07.2025 with their wish and will.

8. Learned Counsel for Petitioners submits that the parties have been happily living together for the last two months, since July, 2025 and have no grievance against each other. Since Respondent No. 2 has already made a statement before the Court that she does not want to pursue the proceedings in FIR, the present Petition be allowed and FIR No.0725/2023 be quashed.

9. In view of Settlement Deed dated 21.07.2025, present Petition has been filed.

10. Respondent No.2 is present and submits that she has no grievance against the Petitioners and also no objection to the quashing of FIR. She affirms that she is happily living together with Petitioner No.1.

11. In view of the fact that the FIR in question was premised upon a matrimonial dispute between Petitioner No.1/husband and Respondent No.2/ wife, which has been amicably resolved in terms of Settlement dated



21.07.2025. Considering the fact that parties have been living together for last two months and Respondent No.2 has also given no objection to the quashing of FIR, no fruitful purpose would be served in continuing with the proceedings arising out of the FIR.

12. Consequently, FIR No.0725/2023 under Sections 498A/406/34 IPC, registered at PS: Okhla Industrial Area, Delhi and all consequential proceedings emanating therefrom are quashed.

13. The Petition along with pending Application is disposed of.
