1. Mr. Gaurav Pachnanda, learned senior counsel for the applicant has taken the Court through the order passed by this Court on 11.09.2025.
2. He further draws the attention of the Court to paragraph No.6 of the affidavit filed by other side. He then contends that if the name of the buyer is disclosed to the petitioner, the petitioner thereafter, will take appropriate
