1. The petitioner/defendant has filed this petition for directions to the trial court to expedite hearing in the subject suit.

2. Learned counsel for petitioner has taken me through record. It is contended that earlier also petitioner had filed a similar petition, which was allowed to be withdrawn vide order dated 09.09.2025 of this Court, granting liberty to the petitioner to move a formal application before the trial court for expeditious disposal of the suit. Accordingly, the petitioner filed application Annexure-P20 before the trial court explaining the circumstances and requesting for expeditious disposal of the suit.
