1. Learned Counsel for the Respondents has returned with instructions. She submits that in view of the fact that the competent authority has granted security clearance to the Petitioners and its Board of Directors and renewed



air operator permit on a regular basis for 5 years, the *lis* in the present Petition no longer survives.

2. Learned Counsel for the Respondents seeks to rely upon a written communication as received on 27.02.2025 from the Competent Authority in this behalf. The relevant extract is set out below:

“The competent Authorities have granted/renewed the security clearance in respect of M/s Global Vectra Helicorp Limited & its Board of Directors, and accordingly DGCA has renewed their Air opeator [SIC operator] permit on regular basis for a period of 5 years.....”
