1. This is a petition filed under section 11(6) of Arbitration and Conciliation Act, 1996 (hereinafter referred to as the “**Act**”) seeking appointment of an arbitrator to adjudicate the disputes between the parties.
2. The brief facts of the case are that the respondent approached the petitioner for the grant of business loan. Subsequently, the parties entered into a Loan Agreement dated 31.08.2023, for a sum of Rs. 35,31,252/-. The said amount was then disbursed to the respondents. Respondent No. 1 is a proprietorship concern of respondent No. 2 and respondent No. 3 is the co-borrower.
3. The said Loan Agreement contains an arbitration clause being Clause No. 8.2 which reads as under:

“8.2 Arbitration : Any disputes, differences, controversies



and questions directly or indirectly arising at any time hereafter between the Parties or their respective representatives or assigns, arising out of or in connection with this Agreement (or the subject matter of this Agreement), including, without limitation, any question regarding its existence, validity, interpretation, construction, performance, enforcement, rights and liabilities of the Parties, or termination (“Dispute”), thereof shall be finally settled by arbitration in accordance with The Arbitration and Conciliation Act, 1996, as amended ('-Arbitration Act'). The dispute shall be referred to a sole arbitrator duly appointed by the parties with mutual consent failing which the sole arbitrator shall be appointed in accordance with Arbitration Act. The language of the arbitration shall be English. The seat of the arbitration shall be at Delhi and the language of proceedings shall be English. The award rendered shall be in writing and shall set out the reasons for the arbitrator’s decision. The costs and expenses of the arbitration shall be borne equally by each Party, with each Party paying for its own fees and costs including attorney fees, except as may be determined by the arbitration tribunal. Any award by the arbitration tribunal shall be final and binding.”

4. Since there disputes between the parties, the petitioner invoked arbitration vide legal notice dated 14.08.2025 and thereafter, the present petition has been filed.
5. No reply has been filed by the respondents and there is nobody



appearing on behalf of the respondents.

6. The respondent is served at the email IDs being pknagar0001@gmail.com and reetasingh67@gmail.com, as per the details of the borrowers.
7. I am of the view that there exists a valid arbitration clause and there are disputes between the parties which need to be adjudicated through the arbitral mechanism.
8. For the said reasons, the petition is allowed and the following directions are issued:-
 - i) Ms. Bhawna Khanna (Advocate) (Mob. No. 9810071710) is appointed as a Sole Arbitrator to adjudicate the disputes between the parties.
 - ii) The arbitration will be held under the aegis and rules of the Delhi International Arbitration Centre, Delhi High Court, Sher Shah Road, New Delhi (hereinafter, referred to as the 'DIAC').
 - iii) The remuneration of the learned Arbitrator shall be in terms of DIAC (Administrative Cost and Arbitrators' Fees) Rules, 2018.
 - iv) The learned Arbitrator is requested to furnish a declaration in terms of Section 12 of the Act prior to entering into the reference.
 - v) It is made clear that all the rights and contentions of the parties, including as to the arbitrability of any of the claim, any other preliminary objection, as well as claims/counter-claims and merits of the dispute of either of the parties, are left open for adjudication by the learned arbitrator.
 - vi) The parties shall approach the learned Arbitrator within two weeks from today.



10. The present petition is disposed of in the aforesaid terms.
