226 of the Constitution of India seeking quashing of the impugned speaking



order dated 20.08.2025 in W.P.(C) 18140/2025 and orders dated 19.08.2025 in other connected writ petitions, whereby admissions under EWS category for academic session 2025-26 have been cancelled as also appellate orders dated 30.08.2025 passed by the District Admission Monitoring Committee.
