Through the present connected Writ Petitions, filed under Article 226 read with Article 227 of the Constitution of India, the Petitioner prays for issuance of direction to the Chairperson, learned Debts Recovery Appellate Tribunal, Calcutta [**“DRAT, Calcutta”**], to expeditiously dispose of the two Appeals filed by the Petitioner.
