1. This hearing has been heard through hybrid mode.
2. The present appeal has been filed by the Appellant – Lakhan under Section 374(2) of the Code of Criminal Procedure, 1973 against the judgment and order on sentence dated 14th January, 2011 and 28th January, 2011 respectively passed by Id. Additional Sessions Judge, Dwarka Courts, Delhi, in Session Case No. 10/10 arising out of FIR No. 07/2010 registered under Section 376/506/342 IPC.
3. The Appellant was convicted under Section 376 and 506 IPC. It is submitted that the Appellant was released from jail on 2nd January, 2017 after completing the sentence awarded to him.
4. The Appellant states that he does not wish to press this appeal on the ground that it has become infructuous as he has already served his sentence.
5. The Appellant has been identified by SI Sanjay Kumar, PS Dwarka (North). After questioning the Appellant, this Court is satisfied that he is



making the statement after knowing the consequences of the same as he has been made aware of the consequences of his statement.
