1. Learned counsel for the respondent-Municipal Corporation of Delhi ("MCD") submits that the present writ petitions have become infructuous, as the licenses of the petitioners have been cancelled *vide* letters dated 08th April, 2025. The aforesaid letters are taken on record.
2. The letter dated 08th April, 2025, issued to the petitioner in W.P.(C) 4859/2018, is reproduced as under:

Subject:- Cancellation/Revocation of Licence of Shop no.07, Sec-III M B Road, Asian Market, New Delhi-110017.

Whereas Shop no. 07, Sector-III Market, MB Road, New Delhi-110017 was allotted to you on lease and licence basis with the terms and conditions as stipulated in the Licence Deed executed by you at the time of allotment.

And whereas you have failed to comply with the terms and conditions of the allotment on account of the "Non payment of licensee fee".

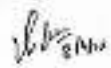
Whereas various notices were issued to you 20.10.2020 & 30.03.2023 to show cause as to why the allotment of Shop no. 07, Sec-III Market, M B Road, New Delhi-110017 may not be revoked/terminated on account of non-compliance of the stipulated terms and conditions. However, you have failed to respond and offer valid explanation within the prescribed period despite the opportunity given to you.

You are further directed to pay outstanding dues immediately failing which appropriate action for recovery shall be taken.

Since, you have failed to comply with the terms and conditions of the allotment of the shop/stall as stated above, I am directed to give you a notice of 90 days from the date of issue to this letter that the licence of the aforesaid, viz Shop no. 07, Sec- III M B Road, New Delhi-110017 shall cease and stand revoked/terminated on the expiry of the 31st day of July 2025. You are therefore, directed to hand over vacant and peaceful possession of the said premises to the JN(Maint-3), South Zone on or before expiry of the notice period. If you fail to handover the vacant possession of the said premises including the portion occupied by the sharer, if any on before the date mentioned above positively, necessary action to evict you under the Public Premises(Eviction of Unauthorized Occupants) Act 1971 will be taken.

Further in accordance with the Licence Deed executed by you, you are liable to payment of damages at the rate of existing licence fee+50% p.m. for the period of overstay, i.e. from the revocation/termination of the licence till the premises are vacated by you or got vacated.

And whereas you have failed to comply with the terms and conditions of the allotment on account of the **"Non-payment of licence fee"**.

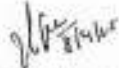

However, you have failed to respond and offer valid explanation within the prescribed period despite the opportunity given to you.

You are further directed to pay outstanding dues immediately failing which appropriate action for recovery shall be taken.

Since, you have failed to comply with the terms and conditions of the allotment of the shop/stall as stated above, I am directed to give you a notice of **90 days** from the date of issue to this letter that the licence of the aforesaid, viz Shop no. 06, Sec- III M B Road, New Delhi-110017 shall cease and stand revoked/terminated on the expiry of the 31st day of July 2025. You are therefore, directed to hand over vacant and peaceful possession of the said premises to the JE(Maint-I), South Zone on or before expiry of the notice period. If you fail to handover the vacant possession of the said premises including the portion occupied by the sharer, if any on before the date mentioned above positively, necessary action to evict you under the Public Premises(Eviction of Unauthorized Occupants) Act 1971 will be taken.

Further in accordance with the Licence Deed executed by you, you are liable to payment of damages at the rate of existing licence fee+50% p.m. for the period of overstay, i.e. from the revocation/termination of the licence till the premises are vacated by you or got vacated.
