for quashing the order dated 05.12.2019, issued

Officer vide memo no. 4079 Dated 05.12.2019,
whereby the selection of the petitioner on the*



post of Anganbadi Sevika at Ward No. 11, Gram Panchayat Bankatwa, East Champaran has been cancelled and it has also been ordered to issue fresh advertisement for the same post.

The order impugned has been passed without Giving any single notice/ opportunity of hearing to the petitioner and also ignoring all the letters/ their own reports earlier sent to the authorities and also against the affidavit filed before Patna High Court by the answering respondents themselves and also without assigning any reason to controvert their on findings earlier, for the reasons best known to them.
