A.P.P. for the State.

2. Petitioners seek regular bail in connection with
Dhaka P. S. Case No. 279 of 2025 in a case registered for the
offences punishable under Sections 191(2), 191(3), 190, 109,
103(1), 61(2) of the Bharatiya Nyaya Sanhita.

3. As per prosecution story, the informant alleged that
on 04.06.2025 all the F.I.R. named accused, including these
petitioners, came to the house of informant, abused and
assaulted his father with Bamboo stick and *Laathi*, as a result of
which he died during course of treatment.

4. Learned counsel for the petitioners submits that



specific allegation of assault is against co-accused Abhishek @ Abhishek Jaiswal, who is alleged to have assaulted the father of the informant with Bamboo stick and *Lathi*. It is further submitted that there is general and omnibus allegation against these petitioners and no specific allegation has been attributed against them. Similarly situated co-accused, namely, Golu Kumar has already been granted regular bail by this Court *vide* order dated 14.11.2025 passed in Cr. Misc. No. 74048 of 2025. Petitioners are in custody since 30.08.2025.

5. Learned A.P.P. for the State vehemently opposed the bail application.

6. Considering the nature of allegation and period of custody, the bail application is allowed. Let the above named petitioners be released on bail on furnishing bail-bond of Rs. 10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of Sub-Divisional Judicial Magistrate, Sikrahna, Dhaka, East Champaran in connection with Dhaka P. S. Case No. 279 of 2025.
