*(iv) grant any other incidental or consequential relief/reliefs to which the*



*Petitioner may be found entitled in the facts  
and circumstances of the case;  
(v) or any other relief or reliefs to which the  
Petitioner is found fit and entitled.*

3. Ms. Pooja Pathak submits that the grievance stands redressed and as such the writ petition has become infructuous.
