32 09-01-2026 Heard Mr. Jai Prakash Singh, learned counsel for the petitioner, Mr. Umeshanand Pandit, learned A.P.P. for the State and Mr. Rajni Kant Singh, learned counsel for the informant/Opposite Party No. 2.

2. This petition has been filed for modification of order dated 21.11.2019 passed in *Cr. Misc. No. 57283 of 2019* by this Court, whereby this Court has granted provisional bail to this petitioner.

3. At the outset, learned counsel appearing on behalf of the petitioner submits that the dispute between the parties has



been resolved.
